Committee and Bylaw Updates

Chair opened the meeting with encouraging the membership to participate in elections.

Bylaw Update:

New language reads:

The Nominations and Elections Committee should solicit input from the membership and then submit a list of nominees for each position to the full membership by email at least 30 days prior to the annual meeting. Voting shall be open to the entire paid membership and shall be completed by one, or combination, of the following: email, web-based voting platform or service, and in-person paper ballot. Voting instructions and deadlines shall accompany the announcement of nominees. The candidates receiving the highest number of votes up to the number of Directors to be elected shall be elected. Votes will be tallied by the Nominations and Elections Committee on or by the first day of the annual meeting and presented to the current Board of Directors. Newly elected Officers and Directors shall join the incumbent Directors at the Board of Directors meeting and shall assume their duties for their 2-year term at that time.

Comments/Questions from the membership about the new language:

- How do you make sure that someone doesn't vote twice through an anonymous system?
 - Answer: The online anonymous voting would be through a program that allows only one vote per person and only by invitation. The program would prevent double voting.
- Another member asked when new board members' positions start.
 - Answer: positions start immediately once announced. In the best-case scenario, they would overlap with the outgoing board members at the board meeting.

Membership voted in favor of the bylaw change
