Special thanks to the organizing committee for putting on a great meeting!

At this year's meeting we had 167 registered to attendees - 117 in person (98 professionals and 20 were students).

We would love to have more students so please help us spread the word.

50 people attended virtually. Having the virtual component has been very popular – the Gather. Town platform has been great.

We had Sponsors: Gold = 4, Silver = 6, Bronze = 4, Virtual = 4

The meeting hosts worked very hard this well to get sponsorship. We've never had this level of sponsorships at our meetings. That money goes into our account to support this and future meetings.

Elections update:

In 2023, 6 board member positions were up for election, including the officer positions of President and Treasurer and 4 Board Member at Large positions held by Dr. Tim Carter, Jocelyn Karsk, Jeremy Sheets, and Sarah Stankavich.

- Brianne Walters is stepping down as Treasurer. Joe Johnson, a current board member, was appointed by the board as treasurer.
- 3 board members were reelected Tim Cater, Jocelyn Karsk, and Jeremy Sheets.
- 2 new board members were elected Julia Wilson and Tara Hohoff welcome!

We need to increase membership voting efforts. In 2023 we only had 29 members vote, 2021 - 46, 2022 - 37. The board is here to represent all of our members and fulfill your requests, but we need your participation and help. You will hear more from us on this so please watch for that and think about participating in the future.

The BOD met this morning from 7 - 9 am CST. The meeting notes will be posted to our website.

Treasurer Report:

Brian Heeringa is our webmaster with the help of Jeremy Sheets. Our website has been revamped in the past few years - please check it out if you haven't. We are going to be bumping up our number of contacts from 250 (\$648/year) to 500 (\$1188/year). The fee to maintain our domain is also up for renewal for \$17.99/year. Finally, the annual subscription to Wild Apricot will increase to \$810/year.

Membership update:

As of 3/22/23, we have 108 members that have paid dues. This number has gone down over the years (and this is happening with other organizations, too), but what else can we do to keep members and attract new members?
