• Government sequester has caused a lot of travel cancellations. We're glad to see as many participants here as were able to come.

Summary of Invited Speakers

Andy King (USFWS) gave national and regional updates on white-nose syndrome. The northeast USA has experienced an overall 88% decline in bats, while the Midwest has been slower to realize declines, with initial reports coming from Ohio and Indiana. There are 7 committees engaged in implementing the National WNS Plan (www.whitenosesyndrome.org) with opportunities for involvement. Accomplishments and tasks include a national bat monitoring program, captive management options, artificial hibernacula, WNS-Risk Ranking Framework for Cavernicolous Bats, and more. Andy also talked about listing assessments for northern long-eared bats, small-footed bats, and little brown bats. Status assessments and a listing decision are due 9/30/2013.

Andy King also discussed updates on the USFWS's proposed revisions to the 2007 Indiana bat summer survey protocols. All public review comments will be posted on the USFWS Indiana bat website (<u>http://www.fws.gov/midwest/Endangered/mammals/inba/index.html</u>). There were



approximately 1,000 comments that were organized into themes for consideration. The Team developed a 2013 Contingency Plan. As an alternative to acoustics, the Team explored a mistnetting Presence/Absence survey option for 2013. A "Draft 2013 MYSO Summer Survey Guidance Overview" has been prepared and submitted for FWS review. Andy presented what was available for release at the time.

Newly proposed 2013 Phased Approach (Contingency Plan):

- Phase 1 Initial Project Screening (coordinate up front with USFWS; habitat assessment [desktop assessment is OK]; assess potential for adverse effects to MYSO can avoidance and minimization measures be employed that would not lead to Incidental Take? Project proponents can always assume presence and not do surveys).
- Phase 2 Presence/Absence Surveys: mistnetting only (Team considered required level of effort) or acoustic surveys as previously proposed: optional coarse screening: calls >35kHz; additional analysis at sites with HF calls using 2 or more available software programs; if any probable MYSO detections (by any program) you can (1) conduct qualitative visual identification, (2) assume presence and coordinate with USFWS, or (3) assume presence and proceed to Phase 3 (netting). Final part is not ready to be presented yet must get regional FWS approval first.
- Phase 3 conduct mistnetting to capture bats
- Phase 4 Radio-tracking and Emergence Counts

Next steps:

- Finalize overview and guidelines (need agency approval).
- Finalize standard testing criteria and test call library and run tests of currently available acoustic ID software programs for official use in 2014 and beyond.
- Finalize new survey guidelines (fall 2013 or early 2014) for implementation in 2014.

There were many questions and comments that followed.

Next on the schedule was an Acoustics Seminar in which David Riggs (Wildlife Acoustics) presented *Bat species identification from zero crossing and full spectrum echolocation calls using HMMs, Fisher Scores, unsupervised clustering and balanced winnow pairwise classifiers: What Bat is That?* He gave a demonstration of the Kaleidoscope software program. Ryan Allen (Bat Call Identification, Inc.) followed up and presented *BCID: Overview to a realistic approach for automated acoustic identification.* He then gave a demonstration of the Bat Call Identification software program.

Meeting Summary

Day One: there were 4 oral presentations in the Acoustics session, followed by two demonstrations: Use of UV for WNS Field Tests and Hands On Demo of UV Methods by J. Gumbs (BATS Research Center). Breakfast and breaks were sponsored by Cardno JF New and Wildlife Acoustics, respectively. The poster session was held concurrently with the evening social sponsored by Organization for Bat Conservation.



Day Two: there were 8 oral presentations on a variety of bat research topics, state reports, and the Business Meeting (notes below). Breakfast and lunch were sponsored by Titley Scientific and Illinois Department of Natural Resources, respectively.
